ORDINANCE NO. 1482

WHEREAS, the Slidell City Council did receive a petition from  
Mr. D. R. Smart, requesting the zoning change from A-6 Single Family Urban  
to C-4 Highway Commercial, and

WHEREAS, the Slidell Planning Commission, in a letter dated  
November 17, 1981, approved such a zoning change, and by a publication  
in the Daily Sentry News on December 27th, January 3rd, and January 10,  
1982, the Council gave notice of their intention to take action on said  
petition by calling a public hearing on January 12, 1982, in the City  
Council Chambers,

NOW THEREFORE BE IT ORDAINED by the Slidell City Council, in legal  
session convened, that the following described property be zoned C-4 Highway  
Commercial:

Beginning at the southwest corner of Broadmoor Park Subdivision,  
as per plat of survey by H. G. Fritchie, C.E., dated June 15,  
1959, said point purported to be South 89 degrees, 52'00"E 1058.  
64 feet and due South 2592.90 feet from the corner common to  
Sections 2, 3, 10 & 11, T9S-R14E, Greensburg Land District, in the  
City of Slidell, St. Tammany Parish, Louisiana; thence run S89°  
51'00"W 122.40 feet to an iron stake; thence, run N00° 01'36"E  
317.60 feet to an iron stake; thence, run N89° 56'39" West 200.00  
feet to an iron stake; thence, run S01° 08'21"W 28.60 feet to an  
iron stake; thence, run S01° 08'21"W 69.00 feet to an iron stake  
at the point of beginning of the property thereafter described.  
From said point of beginning, continue S01° 08'21"W a distance of  
220.00 feet to an iron stake on the northerly right-of-way line  
of Fremaux Avenue; thence run S89° 45'41"W a distance of 150.00  
feet along said right-of-way to an iron stake; thence run N01°  
N89° 45'41E a distance of 150.00 feet to the point of beginning  
of the property herein described; Containing 0.76 acres, more or less.
