ORDINANCE NO. 1541

An ordinance amending Chapter Nine, Crimes - Miscellaneous, and Ordinance No. 1382 of the Code of Ordinances of the City of Slidell.

BE IT ORDAINED by the Slidell City Council, in legal session convened, that Chapter 9 - Crimes - Miscellaneous and Ordinance No. 1382 of the Code of Ordinances of the City of Slidell is amended as follows:

Article 38 of said code is amended to read as follows:

It shall be unlawful for any person to commit the crime of issuing worthless checks. Issuing worthless checks is the issuing, in exchange for anything of value, whether the exchange is contemporaneous or not, with intent to defraud, of any check, draft or order for the payment of money upon any bank or other depository knowing at the time of the issuing that the offender has not sufficient credit with the bank, or other depository for the payment of such check, draft or order in full upon its presentation.

The offender's failure to pay a check, draft, or order issued for value, within ten days after notice of its nonpayment upon presentation has been deposited by certified mail in the United States mail system addressed to the issuer thereof either at the address shown on the instrument or the last known address for such person shown on the records of the bank upon which such instrument is drawn, shall be presumptive evidence of his intent to defraud.

In addition to any other fine or penalty imposed under this Section, the Court may, at its discretion, order as part of the sentence, restitution in the amount of the check or checks.
