5 WHEREAS, the Slidell City Council did receive a petition from Mr. &

7 Mrs. Raymond Laviolette, requesting the annexation and zoning from Parish to

9 C-2, Neighborhood Commercial Zoning District, and

11 WHEREAS, the Slidell Planning & Zoning Commission, in a letter dated

13 September 21, 1982, approved such annexation and zoning, and by a publication

15 in the Daily Times on October 1st, October 4th, and October 10th, 1982, the

17 Council gave notice of their intention to take action on said petition by

19 calling a public hearing on October 26, 1982, in the Council Chambers,

21 NOW THEREFORE BE IT ORDAINED by the Slidell City Council in legal

23 session convened, that the following described property be annexed into

25 Councilmanic District E and zoned C-2:

27 A CERTAIN PORTION OR LOT OF GROUND, together with all the buildings
28 and improvements thereon, and all the rights, ways, privileges,
29 servitudes, appurtenances, and advantages thereunto belonging
30 or in anywise appertaining, situated in the Parish of St. Tammany,
31 State of Louisiana, in Robbert Park Subdivision and which said
32 parcel of ground is designated as a reserved area and Lot Number
33 2 and Square Number 1, Annex Number 2, Robbert Park Subdivision,
34 Eighth Ward, St. Tammany Parish, Louisiana, all in accordance with
35 plan and survey of official maps of said subdivision lying and
36 being situated in the Northeast quarter of Section 12, Township
37 9 South, Range 14 East. Said portion of ground measures 150'
38 front on Tyler Drive by a depth of 150' between equal and parallel
39 lines in a westerly direction. All in accordance with plan and
40 survey prepared by John J. Sollberger, C. E., and surveyor, as
41 approved by the St. Tammany Parish Police Jury, Annex Number 2,
42 Survey 2562, dated May 18, 1959, a copy of which is on file
43 in the office of the Clerk of Court of St. Tammany Parish,
44 Louisiana, and in accordance with the survey of Ivan Borgen dated
45 3 August 1982.

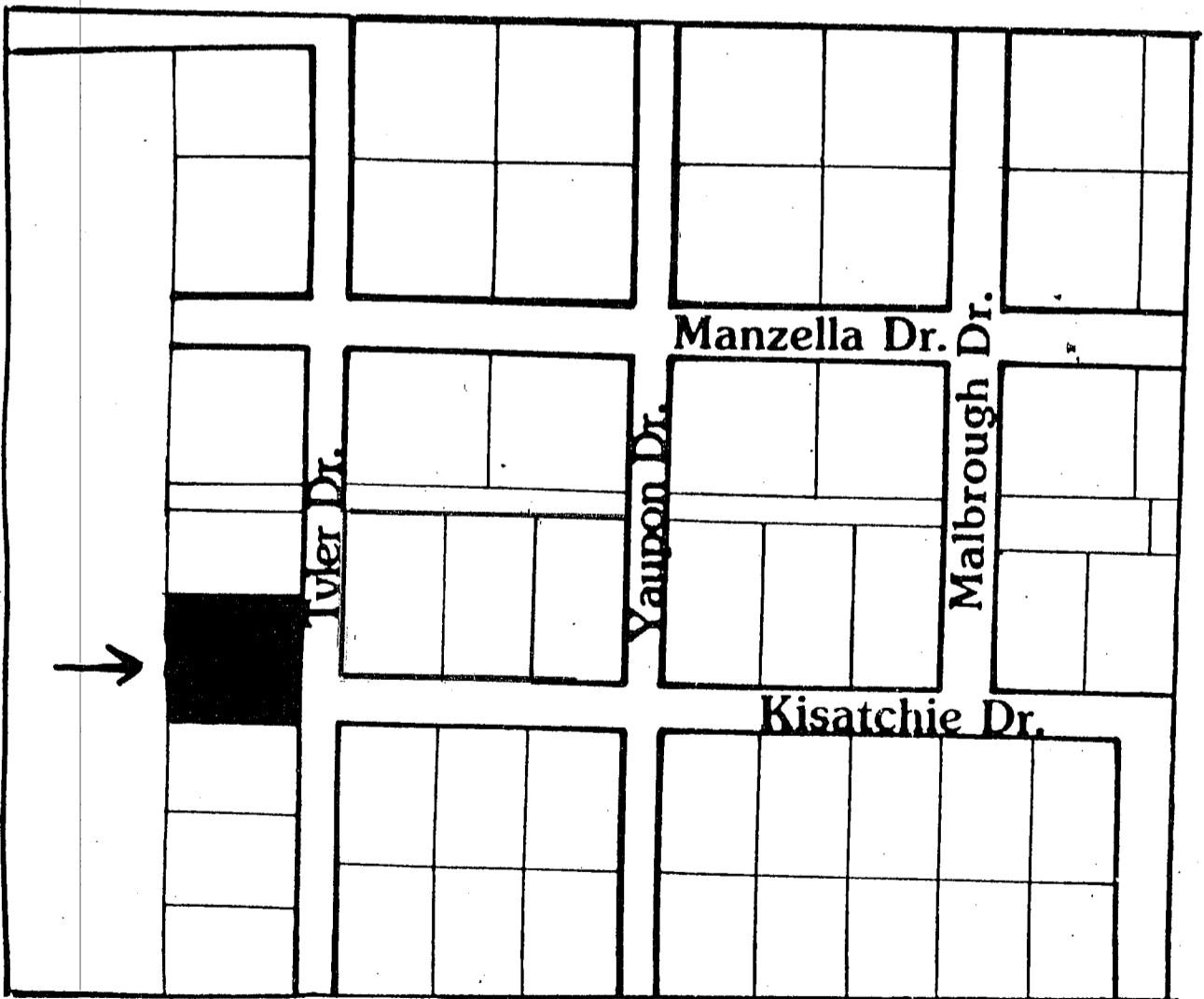
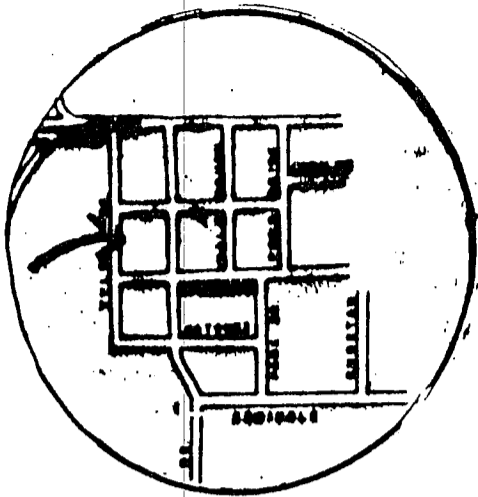


