## ORDINANCE NO. 1659

WHEREAS, the Slidell City Council did receive a petition from Mr. Roger H. Ogden and Mr. James Ogden requesting the annexation and zoning from Parish to C-2 Neighborhood Commercial Zoning District, and;

WHEREAS, the Slidell Planning and Zoning Commission, in a letter dated November 15, 1983, approved such annexation and zoning, and by a publication in the Slidell Daily Sentry News on October 26th, 1983, October 30, 1983 and November 6th, 1983 the Council gave notice of their intention to take action on said petition by calling a public hearing on November 22nd, 1983, in the Council Chambers.

NOW, THEREFORE, BE IT ORDAINED, by the Slidell City Council, in legal session convened, that the following described property be annexed into Councilmanic District G and zoned C-2:

ALL that certain parcel of land being situated in Section 36, Township 8 South, Range 14 East, St. Tammany Parish, LA., being more fully described as follows: From a point, that point being the intersection of the Westerly right-of-way line of Robert Road and the Southerly right-of-way line of Interstate 12, that point also being the point of beginning; thence go in a straight line Northeasterly direction 300 feet more or less to a point, that point being the intersection of the Westerly right-of-way line of Robert Road and the Northerly right-of-way line of Interstate 12; thence following the Westerly right-of-way line of Robert Road go in a Northeasterly direction to a point, that point being the intersection of the Westerly right-of-way line of Robert Road and the Southerly rightof-way line of Brownswitch Road; thence go in a Easterly direction in a straight line course 210 feet more or less to a point, that point being the intersection of the Easterly right-of-way line of Robert Road and the Southerly right-of-way line of Brownswitch Road; thence continuing along said right-of-way; thence continue along said right-of-way line North 89 degrees, 14 minutes, 24 seconds East 410.00 feet to a point; thence South 00 degrees, 45 minutes, 36 seconds East 160.0 feet to a point; thence South 89 degrees, 14 minutes, 24 seconds West 70.00 feet to a point; thence South 00 degrees, 45 minutes, 36 seconds East 432.62 feet to a point; thence South 89 degrees, 14 minutes, 24 seconds West 340.37 feet to a point; thence North 45 degrees, 45 minutes, 36 seconds West 110.96 feet to a point; thence South 89 degrees, 14 minutes, 24 seconds West 56.00 feet to a point; thence South 89 degrees, 14 minutes, 24 seconds West 19.60 feet to a point; thence North 70 degrees, 01 minutes, 46 seconds West 109.17 feet to a point, that point lying on the Easterly right-of-way of Robert Road; thence following the easterly right-of-way line of Robert Road go in a Southwesterly direction 120 feet more or less to a point that point being the intersection of the Easterly right-of-way line of Robert Road and the Northerly right-of-way line of Interstate 12; thence go in a Southwesterly direction in a straight line 300 feet more or less to a point, that point being the intersection of the Southerly right-of-way line of Interstate 12 and the Easterly right-of-way line of Robert Road; thence go in a Westerly direction along the Southerly rightof-way of Interstate 12, 220 feet more or less to a point, that point being the point of beginning.

The provisions of this Ordinance shall become effective December 1, 1983.
