ORDINANCE NO. 1666

WHEREAS, the Slidell City Council did receive a petition from Mr.
William Kurtz, requesting the annexation and zoning change from Parish to A-9
Apartment Commercial Zoning District, and;

WHEREAS, the Slidell Planning and Zoning Commission, in a letter dated
January 18, 1984, approved such annexation and zoning, and by a publication in the
Slidell Sentry News on January 1, 1984, January 8th, 1984 and January 15th, 1984,
the Council gave notice of their intention to take action on said petition by
calling a public hearing on January 24th, 1984 in the Council Chambers.

NOW, THEREFORE BE IT ORDAINED by the Slidell City Council, in legal
session convened, that the following described property be annexed into Councilmanic
District D and zoned A-9:

ALL that certain parcel of land being designated as Lot B, being
situated in Section 4, Township 9 South, Range 14 East, St. Tammany
Parish, Louisiana being more fully described as follows:
From the quarter corner common to Sections 4 and 9 in said Township
and Range, go East 955.70 feet to a point; thence go North 00 degrees,
45 minutes, 00 seconds West 1617.00 feet to a point; thence go
North 87 degrees, 03 minutes 47 seconds East 466.45 feet to a point;
thence go North 01 degrees, 45 minutes, 00 seconds East 84.89 feet
to the point of beginning. Thence from the point of beginning continue
North 01 degrees, 45 minutes, 00 seconds East 459.51 feet to the
Southerly right-of-way line of Old Convington Highway; thence go
along said right-of-way line being North 62 degrees, 43 minutes 05
seconds East 350.10 feet to the Southerly right-of-way of U.S.
Highway 190; thence go along said Southerly right-of-way line of U.S.
Highway 190 being South 70 degrees, 13 minutes 09 seconds East 192.23
feet to the West Bank of Bayou Vincent; thence go along said West
Bank in Seven Courses:

South 03 degrees 07 minutes 00 seconds West 90.41 feet;
South 32 degrees 07 minutes 00 seconds East 66.35 feet;
South 70 degrees 27 minutes 00 seconds East 117.90 feet;
South 46 degrees 53 minutes 00 seconds East 151.00 feet;
South 30 degrees 50 minutes 00 seconds East 80.70 feet;
South 11 degrees 08 minutes 00 seconds East 128.40 feet;
and South 01 degrees 39 minutes 00 seconds East 75.91 feet;
thence go North 89 degrees, 45 minutes, 00 seconds West 838.20 feet
back to the point of beginning.

Containing in all 8.81 acres of land, more or less.



