4 WHEREAS, the Slidell City Council did receive a petition from

6 Mr. Tim O'Neil for the annexation and zoning change from Parish to C-2
7
8 Neighborhood Commercial Zoning District, and

10 WHEREAS, the Slidell Planning & Zoning Commission, in a letter

12 dated May 1, 1984, approved such annexation and zoning, and by a

14 publication in the Slidell Sentry News on April 1st, April 8th, and April
15
16 15, 1984, the Council gave notice of their intention to take action on said

18 petition by calling a public hearing on April 24, 1984, in the Council Chambers.

20 NOW THEREFORE BE IT ORDAINED by the Slidell City Council, in legal

22 session convened, that the following described property be annexed into
23
24 Councilmanic District G and zoned C-2:

27 All that certain parcel of land being situated in Section 35 & 36 in
28 Township and Range 14 East, St. Tammany Parish, Louisiana, being more
29 fully described as follows: From the Section corner common to
30 Sections 1, 2, 35 and 36 in said Township and Range go North 415.8
31 feet to a point; thence South 69 degrees, 43 minutes, 18 seconds West
32 206.1 feet to a point; thence North 00 degrees, 13 minutes, 48 seconds
33 East 15.57 feet to the Point of Beginning, said point being on the
34 Northern Right-of-Way Line of Robert Road. Thence along said
35 Northern Right-of-Way Line South 69 degrees, 43 minutes, 18 seconds
36 West 213.1 feet to a point; thence North 00 degrees, 13 minutes,
37 48 seconds East 200.0 feet to a point; thence North 69 degrees, 43
38 minutes, 18 seconds East 213.1 feet to a point; thence South 00
39 degrees, 13 minutes, 48 seconds West 200.0 feet to the Point of
40 Beginning. Containing in all 39,919 square feet of land.
