ORDINANCE NO. 1729

WHEREAS, the Slidell City Council did receive a petition from Mr. M. P. Schneider, requesting the zoning change from M-2 Light Industrial District to Planned Development Zoning Classification, and

WHEREAS, the Slidell Zoning Commission in a letter dated May 22, 1984 approved such a zoning change, and by a publication in the Slidell Sentry News on May 11th, May 18th, and May 25, 1984 the Council gave notice of their intention to take action on said petition by calling a public hearing on June 12, 1984, in the Council Chambers.

NOW THEREFORE BE IT ORDAINED by the Slidell City Council, in legal session convened, that the following described property be zoned Planned Development Zoning Classification:

> All that certain parcel of land situated in Section 44, Township 9 South, Range 14 East, St. Tammany Parish, Louisiana, being more fully described as follows: From the intersection of the Southerly Right-Of-Way of Bayou Liberty Road and the Easterly Right-Of-Way of Canulette Road, thence along said Easterly Right-Of-Way in two (2) courses: South 73 degrees, 30 minutes, 21 seconds West 7.00 feet to a point, thence South 53 degrees, 58 minutes, 00 seconds West 544.50 feet to the Point Of Beginning. Thence South 40 degrees, 56 minutes, 46 seconds West 1,085.38 feet to a point, thence North 46 degrees, 58 minutes, 24 seconds West 719.92 feet to Easterly Right-Of-Way of Canulette Road, thence along said Easterly Right-Of-Way line in three courses: North 55 degrees, 35 minutes, 47 seconds East 802.80 feet to a point; thence North 82 degrees, 33 minutes, 31 seconds East 76.07 feet to a point; thence South 74 degrees, 53 minutes, 57 seconds East 517.66 feet to the Point of Beginning.
