An ordinance amending Ordinance No. 1490, an ordinance amending
Ordinance No. 795, a Zoning Ordinance and Appendix A, Zoning of the
Code of Ordinances of the City of Slidell.

BE IT ORDAINED, by the Slidell City Council, in legal session convened,
that Ordinance No. 1490, an ordinance amending Ordinance No. 795, a Zoning
Ordinance and Appendix A, Zoning, of the Code of Ordinances of the City of Slidell,
is amended as follows:

Page 12, Lines 17-19: C. Delete the words "commonly known as a
mansard roof". ADD: Said signs shall be placed parallel with the roof line.
Signs placed on a roof must meet all size and height specifications contained
in this section and not to exceed thirty (30) percent of the area of the side
of the roof on which said sign is placed. It shall be permissible to place signs
permitted under this section on top of flat roofs.
