1 LOCAL OR SPECIAL ASSESSMENT ORDINANCE NO. 1741 OF 1984
2 OF THE CITY OF SLIDELL, LOUISIANA.

3
4 AN ORDINANCE providing for the levying of local or special assessments
5 on each parcel or lot of real estate abutting: Canulette Road, Bywater
6 Drive, Middlebrook Drive, Island Drive, Jennifer Lane, Lookout Place
7 Grandview Place, Bayouview Place, Little Place, Bonfouca Drive and
8 Bayou Liberty Road, all as set out in a Notice of Intention adopted
9 on May 12, 1983 within the corporate limits of the City of Slidell,
10 Louisiana, in proportion that the frontage of each lot or parcel
11 bears to all the abutting lots or parcels of real estate to be
12 improved by the construction of waterworks facilities in accordance
13 with the provisions of Title 33, Chapter 8, Louisiana Revised Statutes.

15 BE IT ORDAINED be the City Council of the City of Slidell, Louisiana
16 acting as the governing authority of the City:
17

18 SECTION ~~4~~. In compliance with and under the authority of Article 6,
19 Section 36, Louisiana Constitution of 1974, Title 33, Chapter 8, Louisiana
20 Revised Statutes and other constitutional and statutory authority supplemental
21 thereto, the certified statement or report of Cartier and Associates, Inc.,
22 consulting engineers, and the contract awarded for the construction of the water-
23 works facilities within the City of Slidell, Louisiana as hereinafter described,
24 there be and there is hereby, levied a local or special assessment on each lot
25 or parcel of real estate abutting the streets hereinafter described to cover a
26 portion of the cost of construction of the waterworks facilities and appurtenances,
27 including the intersections hereinafter shown, together with all incidental work
28 in connection therewith, including engineer's and attorney's fees, and all other
29 costs incidental thereto, the assessments to be chargeable to each lot or parcel
30 of real estate abutting the improvements, in proportion that the frontage of each
31 lot or parcel bears to all of the abutting lots or parcels of real estate likewise
32 improved on the streets, the assessments to be imposed at the rate of \$ 22.37 per
33 front foot.
