ORDINANCE NO. 1743

WHEREAS, the Slidell City Council did receive a petition from
Regal Health Care Facilities, Inc. & Louisiana Public Facilities Authority,
Inc. Lessee: Tammany Nursing Home, requesting the annexation change from
Parish to C-2 Neighborhood Commercial, and

WHEREAS, the Slidell Planning & Zoning Commission, in a letter
dated July 17, 1984 approved such annexation and zoning, and by a publication in
the Slidell Sentry News on July 1st, July 8th, and July 15, 1984, the Council
gave notice of their intention to take action on said petition by calling
a public hearing on July 24, 1984, in the Council Chambers.

NOW THEREFORE BE IT ORDAINED, by the Slidell City Council, in legal
session convened, that the following described property be annexed into Councilmanic
District E and zoned C-2:

ALL THAT CERTAIN TRACT or parcel of ground, together with all the
buildings and improvements thereon, and all the rights, ways,
privileges, servitudes, appurtenances and advantages thereunto belonging
or in anywise appertaining, situated in Section 12, Township 9 South,
Range 14 East. Lots 3, 4, 5, 6, & 7 of Lindberg Glen, Annex No. 1, and
the West 300 feet of Lots 1 and 2 of Lindberg Glen, Annex. No. 1 and
a parcel of land adjacent to Lot 1, fronting on Lindberg Drive, measuring
90 feet by 210 feet between equal and parallel lines, and more particularly
described as follows: to-wit: From the Northwest corner of the Southwest
one-quarter of the Northwest one-quarter of Section 12, Township 9
South, Range 14 East, which is the point of beginning, go East 90 feet
to a point; thence go North 90 feet to a point on the southerly right-
of-way line of Lindberg Drive; thence go East along Lindberg Drive 210
feet to a point. Thence go South 210 feet to a point; thence
go East 330 feet to a point on the West line of Lindberg Drive;
thence go South along the West line of Lindberg Drive 350 feet;
thence go West 630 feet; thence go North 470 feet to the point of
beginning. Containing in all 6.322 acres of land.
