3 WHEREAS, the Slidell City Council did receive a petition from

5 Equitable Associates, Agent: George Rachel, requesting the annexation and zoning

7 from Parish to C-2 Neighborhood Commercial, and


9 WHEREAS, the Slidell Planning & Zoning Commission, in a letter

11 dated July 22, 1984 approved such annexation and zoning, and by a publication
12
13 in the Slidell Sentry News on September 2nd, 9th, and September 16, 1984, the
14
15 Council gave notice of their intention to take action on said petition by calling
16
17 a public hearing on September 25, 1984, in the Council Chambers.

18 NOW THEREFORE BE IT ORDAINED, by the Slidell City Council, in legal
19
20 session convened, that the following described property be annexed into
21
22 Councilmanic district E and zoned C-2:

25 THAT CERTAIN PIECE OR PORTION OF GROUND, together with all the buildings
26
27 and improvements thereon, and all the rights, ways, privileges, servitudes,
28
29 appurtenances and advantages thereunto belonging or in anywise appertaining,
30
31 situated in the Parish of St. Tammany, State of Louisiana, in LOG CABIN
32
33 Subdivision, Slidell, in Square No. 1, designated as the South half of
34
35 Lot No. 2, which measures 92.5 feet front on Gause Road, the same in width
36
37 in the rear, by a depth of 150 feet between equal and parallel lines, all
38
39 in accordance with the survey of H. G. Fritchie, Parish Surveyor, dated
40
41 November 24, 1958.

42 Further in accordance with survey by Ivan M. Borgen, E.E., dated July 10,
43
44 1984 and being No. 40041 and description as further described by the process
45
46 verbal, both of which are attached herto and made a part hereof.


