19 An ordinance authorizing and empowering M. W. "Webb Hart,  
20 Mayor or the City of Slidell, to purchase on behalf of the City  
21 of Slidell, a parcel of land belonging to Hamilton Meyer and  
22 Associates and Miramon Construction, Inc.  
23

24 WHEREAS, Hamilton Meyer and Associates and Miramon  
25 Construction, Inc. has offered to sell the below described parcel  
26 of land (being 2.08 acres more or less) to the City of Slidell, and;

29 WHEREAS, this Council feels that the purchase of this  
30 parcel of land from Hamilton Meyer and Associates and Miramon  
31 Construction, Inc. will greatly benefit the City of Slidell and  
32 its citizens,  
33

35 NOW THEREFORE BE IT ORDAINED by the Slidell City Council,  
36 in legal session convened, that M. W. "Webb" Hart, Mayor of the  
37 City of Slidell is hereby authorized and empowered to purchase and  
38 receive on behalf of the City of Slidell and to execute all  
39 necessary documents associated with said purchase, for the price  
40 of \$27,600 (twenty-seven thousand six hundred dollars), the following  
41 described property, to-wit:

44 A 2.08 acre parcel of land located in Section 15, Township 9 South,  
45 Range 14 East, St. Tammany Parish, Louisiana, more fully described  
46 as follows:  
47

48 From the southwest corner of Washington Avenue and Claude Street  
49 go 110 feet east along the south boundary of Claude Street to a  
50 point of beginning. From the point of beginning go north 72 degrees  
51 38 minutes 41 seconds east a distance of 691.48 feet along Claude  
52 Street to south 240.95 feet, to north 89 degrees 52 minutes 0 seconds  
53 west 660 feet to north 33.15 feet to the point of beginning in  
54 Section 15, Township 9 South, Range 14 East, St. Tammany Parish,  
55 Louisiana.  
56

57 BE IT FURTHER ORDAINED that this ordinance shall become  
58 effective upon being signed by the Mayor.  
59

60 This ordinance shall become null and void if act of sale has  
61 not been passed on the property in question by April 1, 1985.
