18 WHEREAS, the Slidell City Council did receive a petition from
19
20 Elliot Reynard, requesting the zoning change from A-7 Multifamily Urban
21
22 to C-2 Neighborhood Commercial Zoning District. This property is
23
24 located on the north by 2442 Second Street, on the west by Second
25
26 Street, on the south by Guzman Street and the east by Third Street.


28 WHEREAS, the Slidell Zoning Commission in a letter dated
29
30 December 18, 1985 approved such a zoning change, and by a publication
31
32 in the Slidell Sentry News of January 3, 8, and 15, 1985, the Council
33
34 gave notice of their intention to take action on said petition by
35
36 calling a public hearing on January 22, 1985 in the Council Chambers.

38 NOW THEREFORE BE IT ORDAINED by the Slidell City Council, in
39
40 legal session convened, that the following described property be zoned
41
42 C-2 Neighborhood Commercial Zoning District:

44 A CERTAIN PIECE OR PORTION OF GROUND SITUATED IN THE
45 ROBERT ADDITION TO THE TOWN OF SLIDELL and being Lots 7
46 and 8 of Square 29 therein, St. Tammany Parish, Louisiana,
47 and more fully described as follows:


49 Beginning at the intersection of Guzman Street and Second
50 Street, go Easterly along the Northern edge of Guzman
51 Street 60.0 feet to a point on a concrete walk; thence
52 at a right angle go Northerly and parallel to Second Street
53 120.0 feet to a fence post; thence at a right angle go
54 Easterly and parallel to Guzman Street 90.0 feet to a
55 fence post; thence at a right angle go Northerly and parallel
56 to Second Street 60.0 feet to an iron stake; thence at a
57 right angle go Westerly 150.0 feet to an iron stake located
58 on the Eastern edge of Second Street; thence at a right
59 angle go Southerly along the Eastern edge of Second Street
60 180.0 feet to a point on concrete and the point of
61 beginning.


