17 An ordinance (Amendment A) amending Ordinance Number 1741,
18 an ordinance providing for the levying of local or special assessments
19 on each parcel or lot of real estate abutting: Canulette Road,
20 Bywater Drive, Middlebrook Drive, Island Drive, Jennifer Lane,
21 Lookout Place, Grandview Place, Bayouview Place, Little Place,
22 Bonfouca Drive and Bayou Liberty Road, all as set out in a Notice
23 of Intention adopted on May 12, 1983 within the corporate limits
24 of the City of Slidell, Louisiana, in proportion that the frontage
25 of each lot or parcel bears to all the abutting lots or parcels
26 of real estate to be improved by the construction of waterworks
27 facilities in accordance with the provisions of Title 33, Chapter
28 8, Louisiana Revised Statutes.

30 BE IT ORDAINED by the Slidell City Council, in legal session
31 convened, that Ordinance No. 1741, an ordinance providing for the
32 levying of local or special assessments on each parcel or lot of
33 real estate abutting: Canulette Road, Bywater Drive, Middlebrook
34 Drive, Island Drive, Jennifer Lane, Lookout Place, Grandview Place,
35 Bayouview Place, Little Place, Bonfouca Drive and Bayou Liberty Road,
36 all as set out in a Notice of Intention adopted on May 12, 1983
37 within the corporate limits of the City of Slidell, Louisiana, in
38 proportion that the frontage of each lot or parcel bears to all
39 the abutting lots or parcels of real estate to be improved by the
40 construction of waterworks facilities in accordance with the
41 provisions of Title 33, Chapter 8, Louisiana Revised Statutes is






