18 WHEREAS, the Slidell City Council did receive a petition from  
19 F.H.G. Corporation (being generally located at the interesection on the  
20 southside of Old Spanish Trail, Robert Street, and Interstate 10)  
21 requesting annexation and zoning from Parish to C-4 Highway Commercial  
22 Zoning District, and;

23  
24 WHEREAS, the Slidell Planning and Zoning Commission, in a  
25 letter dated February 26, 1985, approved such annexation and zoning,  
26 and by a publication in the Slidell Sentry News on January 29, February  
27 5, and 12, 1985, the Council gave notice of their intention to take  
28 action on said petition by calling a public hearing on February 26,  
29 1985, in the Council Chambers,

32 NOW THEREFORE BE IT ORDAINED, by the Slidell City Council, in  
33 legal session convened, that the following described property be  
34 annexed into Councilmanic District B and zoned C-4:

37 All that certain parcel of land being designated as Lots 1  
38 through 7, Square 3, Lake Gardens Subdivision And Part of  
39 Lots 5 and 6 lying in Blocks 3 and 5, Piazza Farms Subdivision,  
40 Section 44, Township 9 South, Range 14 East, St. Tammany  
41 Parish, Louisiana, being more fully described as follows:

43 From the concrete Louisiana Department of Highways Monument  
44 at the intersection of the Southerly Right-of-Way line of  
45 Robert Street and the Westerly Right-of-Way line of Inter-  
46 state 10 ingress, also the point of beginning, thence along  
47 said Westerly Right-of-Way line South 16 degrees, 51 minutes,  
48 57 seconds East 395.10 feet to a point; thence along the  
49 Westerly Right-of-Way line of Interstate 10 South 07 degrees,  
50 10 minutes, 07 seconds West 194.94 feet to a point; thence  
51 South 87 degrees, 54 minutes, 07 seconds West 268.33 feet to a  
52 point; thence North 00 degrees, 37 minutes, 31 seconds West  
53 218.58 feet to a point on the Northerly Right-of-Way line of  
54 Erb Street; thence North 48 degrees, 08 minutes, 50 seconds  
55 East 22.95 feet to a Point; thence North 41 degrees, 44 minutes  
56 47 seconds West 150.03 feet to a point on the Southerly Right-  
57 of-Way line of Robert Street; thence along said Southerly  
58 Right-of-Way line North 48 degrees, 09 minutes, 07 seconds East  
59 353.07 feet to the Point of Beginning. Containing in all 3.16  
60 acres of land, more or less.

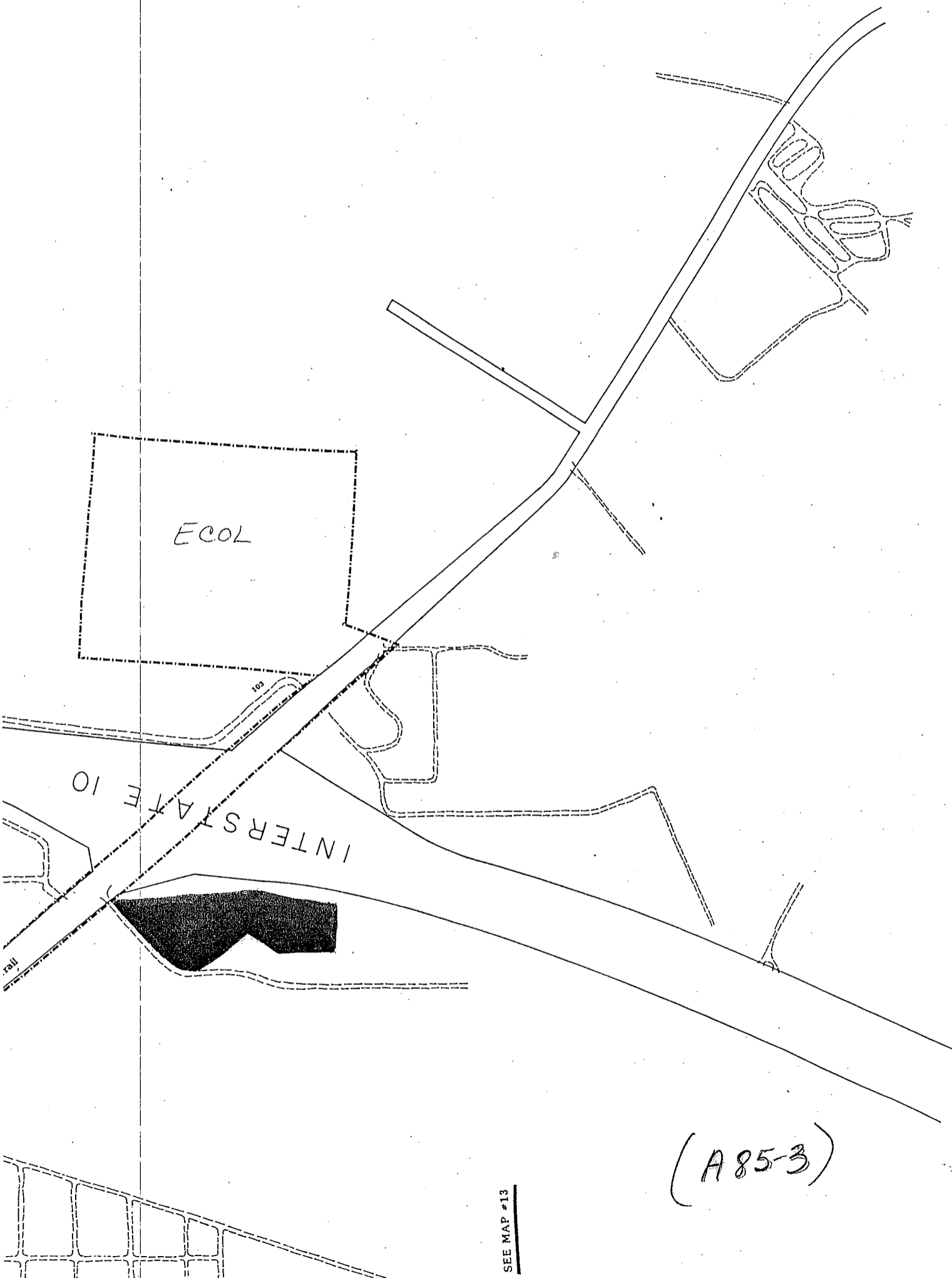
