Said Lot 20 measures approximately 60 feet on the intersection of Rama Street and Terrace Avenue; 75 feet going West from Terrace Avenue, adjoining Lot 19; 100 feet going West from the intersection of Rama Street and Terrace Avenue adjoining Lot 21 to a point on the west line of this subdivision which is also the intersection of the North line of Lot 20.

PARCEL II


