41 NOW THEREFORE BE IT ORDAINED by the Slidell City Council, in
42 legal session convened, that the following described property be zoned
43 C-2 Neighborhood Commercial Zoning District:

47 TWO CERTAIN LOTS OF GROUND, together with all the buildings and
48 improvements thereon, and all the rights, ways, privileges,
49 servitudes, appurtenances and advantages thereunto belonging or
50 in anywise appertaining situated in St. Tammany Parish, Louisiana.
51 LOTS 26 and 27, SQUARE 18, TERRACE PARK SUBDIVISION, City of Slidell,
52 St. Tammany Parish, Louisiana.

55 TWO CERTAIN LOTS OF GROUND, situated in the PARISH OF ST. TAMMANY,
56 STATE OF LOUISIANA, in that part thereof known as TERRACE PARK
