ORDINANCE NO. 1806

An ordinance amending Section 20-7.1. Monthly rates for services; use of funds., of Chapter 20. Water, of the Code of Ordinances of the City of Slidell.

BE IT ORDAINED by the Slidell City Council, in legal session convened, that Section 20-7.1. Monthly rates for services; use of funds., of Chapter 20. Water, of the Code of Ordinances of the City of Slidell, is amended as follows:

Section 20-7.1.

(a): Delete the present language in its entirety and replace with a new subsection (a) as follows: (a) The monthly rate for the service of water to residences and commercial and industrial establishments within the city limits who have no water meters shall be the sum of five dollars and eighty cents (\$5.80) per month. At such time when water meters are installed at said residences and commercial and industrial establishments, water will be billed at the rate as outlined in subsection (b). There shall be no free service to any consumer connected to the water system of the city.

(b): Delete this section in its entirety.

(c): Delete the subsection designation and the present language in its entirety and replace with a new subsection (b) as follows: (b) Where water meters are installed for residences and commercial and industrial users, the following monthly rates shall be charged for water service furnished by the city:


<u>First 5,000 gallons, minimum bill.....</u>	<u>\$5.00</u>
<u>Thereafter, each 1,000 gallons.....</u>	<u>\$0.16</u>


(e): Redesignate this subsection as (d) and delete the words "and sewer".





