19 An ordinance amending Section 2.23. Sign regulation of Appendix
20 A - Zoning of the Code of Ordinances of the City of Slidell.
21

22 BE IT ORDAINED by the Slidell City Council, in legal session
23 convened, that Section 2.23. Sign regulation of Appendix A - Zoning
24 of the Code of Ordinances of the City of Slidell is amended by adding
25 a new Section 2.2310-8 as follows:

28 Section 2.2310-8. Hotels and motels which have at least
29 seventy percent (70%) of their occupancy from transient persons
30 domiciled outside of the greater Slidell area (the postal mailing
31 address areas of Slidell, Lacombe and Pearl River, Louisiana), and
32 which said hotels or motels are not located on one of the following
33 main thoroughfares: Pontchartrain Drive and Front Street (U.S.
34 Highway 11), Old Spanish Trail (La. Highway 433), Gause Boulevard and
35 the extension of Gause Boulevard designated U.S. Highway 190 West,
36 may erect one only off premise sign, not to exceed six (6) feet in
37 height and twelve (12) feet in length, including any frame or border,
38 on private property located on the main thoroughfare, as named above,
39 which is the main thoroughfare nearest to said hotel or motel, as a
40 directional sign to assist persons in locating said hotel or motel.
41 Copy on said sign may contain the name of the hotel or motel, its
42 address, directional copy to said hotel or motel, any emblem of an
43 established franchise or association and times during which the hotel
44 or motel is open. The property on which such off premise sign is
45 located must be zoned C-1, C-2, C-3, C-4, M-1, M-2 or M-3. The sign
46 may have two faces, be illuminated and its total height from ground
47 level may not exceed twelve (12) feet. Such sign must conform with
48 all requirements in Section 2.2302 of this Ordinance.
