24 dedicated as a city street right of way (Carollo Drive):

27 Irregular strip in Sec. 44-9-14 being more fully described  
28 as follows: All that certain lot or parcel of land lying and being  
29 situated in Sec. 44-T 9 S., R. 14 E., City of Slidell, St. Tammany  
30 Parish, Louisiana, more fully described as follows:

32 Commencing at the N. E. corner of Liddle Tract of said Town-  
33 ship and Range go S. 26 degrees 31 W. 202.3 feet to the southerly  
34 right of way line of Carollo Drive which is the point of beginning.  
35 From the point of beginning continue S. 26 degrees 31' West 5.5' to  
36 a point; thence S. 40 degrees 17' East 207.9' to a point; thence S.  
37 26 degrees 31' West 39.6' to a point thence S. 40 degrees 17' East
