19 An ordinance authorizing and empowering Salvatore A. Caruso,
20 Mayor of the City of Slidell, to receive on behalf of the City of
21 Slidell, a parcel of land being donated to the City of Slidell by
22 Dorothy Schneider Marshall.

24 WHEREAS, Dorothy Schneider Marshall has offered to donate the
25 below described parcel of land to the City of Slidell, and;

28 WHEREAS, this Council feels that accepting the donation of this
29 parcel of land from Dorothy Schneider Marshall will greatly benefit the
30 City of Slidell and its citizens,

33 NOW THEREFORE BE IT ORDAINED by the Slidell City Council, in
34 legal session convened, that Salvatore A. Caruso, Mayor of the City of
35 Slidell, is authorized and empowered to accept and receive on behalf
36 of the City of Slidell from Dorothy Schneider Marshall the following
37 described property, to wit:

40 All that certain parcel of land being designated as part of
41 Lot 7, Bayou Bonfouca Estates, Sections IV and V, City of
42 Slidell, St. Tammany Parish, Louisiana, being more fully
43 described as follows:


46 That part of lot 7 can be further described as a waterway
47 approximately 50 feet in width extending from the South,
48 where it begins on the Northern edge of Bayou Lasseigne, and
49 proceeds to the North Northeast, intersection Bonfouca Drive,
50 a 50 foot road, and continues North Northeast until it in-
51 tersects with the property line of land presently owned by
52 Claude W. Schneider, Bernice Schneider Wells and Matthew P.
53 Schneider, Jr. This remaining portion of Lot 7 can further
54 be described as all of that waterway or property lying
55 Westerly of lot 6 with its Westerly most boundary being the
56 rear (Eastern most) property line of lots 15 through 28,
57 inclusive of the public and waterway area in a survey of the
58 subdivision known as Bayou Bonfouca Estates, Sections IV and
59 V.
