20 WHEREAS, the Slidell City Council did receive a petition from
21 Kathleen M. Zeringue requesting the zoning change from A-7 Multifamily
22 Urban to C-2 Neighborhood Commercial Zoning District. Municipal
23 address being 2752 William Tell, and being generally located on the
24 corner of William Tell and Mayfield Street, and;

28 WHEREAS, the Slidell Zoning Commission in a letter dated June
29 20, 1985 approved such a zoning change, and by a publication in the
30 Slidell Sentry News on June 4, 11, and 18, 1985, the Council gave
31 notice of their intention to take action on said petition by calling
32 a public hearing on June 25, 1985, in the Council Chambers;

36 NOW THEREFORE BE IT ORDAINED by the Slidell City Council, in
37 legal session convened, that the following described property be zoned
38 C-2 Neighborhood Commercial Zoning District:

42 (1) ALL THAT CERTAIN LOT OR PARCEL OF LAND, together with all buildings
43 and improvements thereon and all rights, ways, privileges, servitudes,
44 and appurtenances and advantages thereunto belonging or in anywise
45 appertaining, lying and being situated in the Town of Slidell, St.
46 Tammany Parish, Louisiana, more fully described as being Lot 2, House
47 No. 1301, in Block "X" of the First Salmen Addition to the Town of
48 Slidell. Said Lot 2 commences a distance of 60 feet north of the
49 northeast corner of the intersection of William Tell Street and
50 Mayfield Avenue on the eastern right of way line of William Tell Street
51 by a depth of 120 feet in an easterly direction between equal and
52 parallel lines.

55 (2) All that certain lot or parcel of land, together with all buildings
56 and improvements thereon, and all rights, ways, privileges, servitudes,
57 appurtenances and advantages thereunto belonging or in anywise
58 appertaining, lying and being situated in the Town of Slidell, St.
59 Tammany Parish, Louisiana, in a square bounded by William Tell and
60 College Streets and Bilten and Mayfield Avenue and measures 60 feet
61 front on William Tell Street by a depth and front on Mayfield Avenue
62 of 120 feet between equal and parallel lines.
