15 ORDINANCE NO. 1844

18 WHEREAS, the Slidell City Council did receive a petition from  
19  
20 W. T. Eddins on behalf of Bledns, Inc. requesting the zoning change  
21  
22 from A-9-C Apartment Commercial to Planned Development. This property  
23  
24 contains 19.93 acres and is bounded on the west by Bluebird Drive, on  
25  
26 the north by Robin Street, on the east by Timberlane Drive, and on the  
27  
28 south by Savannah Drive, and;

30 WHEREAS, the Slidell Zoning Commission in a letter dated  
31  
32 June 20, 1985 approved such a zoning change, and by a publication in  
33  
34 Slidell Sentry News on June 4, 11, and 18, 1985, the Council gave  
35  
36 notice of their intention to take action on said petition by calling  
37  
38 a public hearing on June 25, 1985, in the Council Chambers;

40 NOW THEREFORE BE IT ORDAINED by the Slidell City Council, in  
41  
42 legal session convened, that the following described property be zoned  
43  
44 Planned Development:

45  
46 All that certain parcel of land being situated in Section 2, Township 9  
47  
48 South, Range 14 East, St. Tammany Parish, Louisiana, being more fully  
49  
50 described as follows:  
51  
52 From the section corner common to Section 1 and 2, Township 9 South,  
53  
54 Range 14 East, and Section 35 and 36, Township 8 South, Range 14 East,  
55  
56 thence South 1,319.0 feet to the Point of Beginning.  
57  
58 Thence South 00 degrees, 00 minutes, 14 seconds West 1,317.72 feet  
59  
60 along the West boundary of Tanglewood Village Subdivision, Phase 2,  
61  
62 to the Southerly right-of-way line of a 50-foot drainage easement;  
63  
64 thence along said Southerly right-of-way line North 89 degrees, 31  
65  
66 minutes, 51 seconds West 659.79 feet; thence along the Easterly  
67  
68 boundary of Audubon Place Subdivision North 1,313.20 feet; thence  
69  
70 South 89 degrees, 55 minutes, 25 seconds East 659.86 ft. along the  
71  
72 Southerly boundary of Audubon Place Subdivision to the Point of  
73  
74 Beginning. Containing in all 19.93 acres of land, more or less.
