25 convened, that Ordinance No. 795 and Appendix A-Zoning of the Code of  
26 Ordinances of the City of Slidell is amended as follows:

29 Part 3. Administration and Enforcement  
30

31  
32 Section 3.1. Lines one (1) and four (4): Delete the words  
33 "City Council" and replace with the word Mayor.  
34

35  
36 Section 3.201: Delete the words "president of the City  
37 Council with the approval of the Council" and replace with the word  
38 Mayor.  
39

41 Section 3.4. Violations  
42

43  
44 Section 3.402. Delete the words and numbers "ten dollars  
45 (\$10.00), nor more than twenty-five dollars (\$25.00)" and replace with  
46 the following language: fifty dollars (\$50.00) nor more than two  
47 hundred dollars (\$200.00).

51 Part 5. Schedule of Fees, Charges and Expenses.

53  
54 Section 5.101.: Delete the words "clerk of the legislative  
55 body" and replace with Director of Planning.  
56

57  
58 In the second to the last line after the word "body." insert  
59 the following sentence: The party or parties proposing or recom-  
60 mending a change in zoning classification shall also be responsible  
61 for the cost of all legal advertisement as may be required by law.



65 In the last line delete the word "resolution" and replace with  
66 the word ordinance.

69 5.102. Add: In addition, the party or parties requesting  
70 B.Z.A. action shall be responsible for the payment of all costs for




