19 An ordinance making application to the State Bond Commission
20 for consent and authority to hold a special election in the City of
21 Slidell, Louisiana, and in the event said election carries, for further
22 consent and authority to renew a three (3) mill tax within said City.
23

24 BE IT ORDAINED by the City Council of the City of Slidell,
25 Louisiana, acting as the governing authority of said City, that:
26

27 SECTION 1. Application be, and the same is hereby formally
28 made to the State Bond Commission, Baton Rouge, Louisiana, for consent
29 and authority to hold a special election in the City of Slidell,
30 Louisiana, under the provisions of Article X, Section 10-A of the
31 Constitution of the State of Louisiana for the year 1921, as amended,
32 Title 39, Sub-Title II, Chapter 4, Louisiana Revised Statutes of 1950,
33 as amended, and other constitutional and statutory authority supple-
34 mental thereto, at which election there will be submitted to all
35 registered voters qualified and entitled to vote at said election
36 under the Constitution and laws of the State of Louisiana, and the
37 Constitution of the United States, the following proposition, to wit:

52 Proposition to renew a levy of a three (3) mill tax on
53 all the property subject to taxation in the City of Slidell,
54 Louisiana, for the period of ten (10) years, beginning
55 in the year 1985 and ending in the year 1994, for the
56 purpose of maintenance and operation of the municipal
57 police department of the City, including the acquisition
58 of the necessary equipment therefor, in accordance with
59 the provisions of Article X, Section 10-A of the Constitution.

61 SECTION 2. Application be, and the same is hereby further made
62 to said State Bond Commission, in the event the aforesaid proposition
63 is carried, for its consent and authority to levy and collect the three
64 (3) mill tax on all the property subject to taxation in the City of
65 City of Slidell.
