21 for and on behalf of the City of Slidell all necessary property for
22 the servitude of drainage for the Northside Lateral project in con-

26 WHEREAS, the aquisition of a servitude of drainage from the
27 Alabama Great Southern Railroad Co., Inc. for the Northside Lateral
28 is a necessary part of the Operation Rainwater project, and;

31 WHEREAS, the Alabama Great Southern Railroad Co., Inc. had
32 previously agreed to sell this servitude of drainage to the City of
33 Slidell for Fifty Thousand and No/100 Dollars (\$50,000), and;

36 WHEREAS, the Alabama Great Southern Railroad Co., Inc. has now
37 offered to sell this servitude of drainage to the City of Slidell for
38 Thirty-Five Thousand and No/100 Dollars (\$35,000)

41 NOW THEREFORE BE IT ORDAINED by the Slidell City Council, in
42 legal session convened, that Mayor Salvatore A. Caruso be and he is
43 hereby authorized to purchase for and on behalf of the City of Slidell
44 all necessary property for the servitude of drainage for the Northside
45 Lateral project in connection with Operation Rainwater.

48 BE IT FURTHER ORDAINED that Mayor Salvatore A. Caruso be and he
49 is hereby authorized to sign all documents deemed necessary by him in
50 order to accomplish this purpose.
