18 WHEREAS, The Slidell City Council did receive a petition from

20 Grace Memorial Baptist Church requesting annexation and zoning from

22 Parish to A-6 Single Family Urban, and being generally located east

24 of Pearl Street, west of Military Road, and south of Gause, and;

26 WHEREAS, the Slidell Planning and Zoning Commission approved

28 such annexation and zoning on October 21, 1985, and by a publication

30 in the Slidell Daily Times on 9-17-85, 9-24-85 and 10-1-85, the City

32 Council gave notice of their intention to take action on said petition

34 by calling a public hearing on 10-22-85 in the Council Chambers;

36 NOW THEREFORE BE IT ORDAINED by the Slidell City Council in

38 legal session convened, that the following described property be

40 annexed in to Councilmanic District E and zoned A-6:

42 A certain lot or parcel of land situated in Section 7, Township 9
43 South, Range 15 East, 8th Ward, St. Tammany Parish, Louisiana
44 being more fully described as follows:

46 From the corner common to Sections 1 and 12, Township 9 South,
47 Range 14 East and Sections 6 and 7, Township 9 South, Range 15 East,
48 proceed S 89 degrees 43 minutes E a distance of 468 feet to a point
49 on the east side of Pearl Street, thence S 0 degrees 1 minute 40
50 seconds W a distance of 30 feet to the point of beginning, thence
51 S 89 degrees 43 minutes E a distance of 500.42 feet, thence S 0 degrees
52 1 minute 40 seconds W a distance of 208.71 feet, thence S 89 degrees
53 43 minutes E a distance of 208.71 feet, thence S 0 degrees 1 minute
54 40 seconds W a distance of 221.29 feet, thence N 89 degrees 43 minutes
55 W a distance of 709.14 feet, thence N 0 degrees 1 minute 40 seconds E
56 a distance of 430 feet to the point of beginning.
