19 BE IT ORDAINED by the Slidell City Council, in legal session
20 convened, that Mayor Salvatore A. Caruso is hereby authorized,
21 requested and directed to sign an Act of Correction between the City
22 of Slidell and Lazard Jacob Levy Jr. amending the description in the
23 act of sale dated February 26, 1973 from the City of Slidell to Lazard
24 Jacob Levy Jr., said act having been before Ronald W. Guth, St.
25 Tammany Parish Notary Public and recorded in C.O.B. 698, Folio 773 of
26 the official records of St. Tammany Parish, Louisiana to read as
27 follows:

30 All that certain portion of ground being a portion of Lot 11,
31 Square 10, Town of Slidell, St. Tammany Parish, Louisiana, and being
32 more fully described as follows: To-wit;

35 From the Southeast corner of said Square 10, Town of Slidell,
36 St. Tammany Parish, Louisiana, which forms the Northwest corner of the
37 intersection of Bouscaren Street and First Street, go North along the
38 East side of said Square 10, which is the East line of Lots 8, 9, and
39 10, one hundred and eighty feet (180') to a point, which is the
40 Southeast corner of said Lot 11 of said Square 10, thence go West
41 sixty-five feet (65') to the point of beginning;

44 From the point of beginning go West forty-five feet (45')
45 to a point; thence go North sixty feet (60') to a point; thence go
46 East forty-five feet (45') to a point; thence go South sixty feet
47 (60') back to the point of beginning.

50 Being a portion of the same property aquired by the City of
51 Slidell from the St. Tammany Parish Police Jury by act dated January
52 5, 1959 before Gus A. Fritchie Jr., St. Tammany Parish Notary Public,
53 and recorded in C.O.B. 268, Folio 615 of the official records of St.
54 Tammany Parish, Louisiana.
