18 WHEREAS, the Slidell City Council did receive a petition from  
19  
20 Dr. Cary F. Gray and Dr. Stanford Allen Owen requesting annexation and  
21  
22 zoning from Parish to C-4 Highway Commercial, and being generally  
23  
24 located east of National Medical Enterprise, north of Gause Boulevard,  
25  
26 and west of Lot 9, Slidell Suburban Acres;  
27

28 WHEREAS, the Slidell Planning and Zoning Commission approved  
29  
30 such annexation and zoning on November 18, 1985, and by a publication  
31  
32 in the Slidell Daily Times on October 29, November 5, and 12, 1985, the  
33  
34 City Council gave notice of their intention to take action on said  
35  
36 petition by calling a public hearing on November 26, 1985, in the  
37  
38 Council Chambers;  
39

40 NOW THEREFORE BE IT ORDAINED, by the Slidell City Council, in  
41  
42 legal session convened, that the following described property be  
43  
44 annexed into Councilmanic District E and zoned C-4:  
45

46 From the corner common to Sections 6 and 7, Township 9 South, Range  
47 15 East and Sections 1 and 12, Township 9 South, Range 14 East;  
48 Thence go North 89 degrees 55 minutes West for a distance of 330.0  
49 feet; Thence North 474.27 feet; Thence South 72 degrees 18 minutes  
50 West for a distance of 540.19 feet; Thence North 31.77 feet; Thence  
51 South 71 degrees 57 minutes 22 seconds West for a distance of 90.02  
52 feet, to the Point of Beginning.

53 From the Point of Beginning go South 71 degrees 56 minutes 04 seconds  
54 West for a distance of 405.09 feet; Thence go South 72 degrees 20  
55 seconds 27 minutes West for a distance of 16.06 feet; Thence go  
56 North a distance of 1,139.27 feet; Thence go South 89 degrees 44  
57 minutes East for a distance of 401.82 feet; Thence go South 0  
58 degrees 04 minutes 45 seconds West for a distance of 1,006.91 feet  
59 to the Point of Beginning.

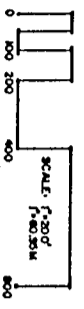
