19 WHEREAS, the Slidell City Council did receive a petition from  
20  
21 Dr. Ronald C. Francis, custodian for minor children: Lisa Therese  
22  
23 Francis, Keith Patrick Francis, and Michael John Francis requesting  
24  
25 rezoning from A-7 Multi-family Urban to A-9-C Apartment Commercial, and  
26  
27 being located on Carey Street between Pontchartrain Drive and Mayfield;  
28

29 WHEREAS, the Slidell Planning and Zoning Commission approved  
30  
31 such rezoning on November 18, 1985, and by a publication in the Slidell  
32  
33 Daily Times on October 29, November 5, and 12, 1985, the City Council  
34  
35 gave notice of their intention to take action on said petition by  
36  
37 calling a public hearing on November 26, 1985, in the Council Chambers;

39 NOW THEREFORE BE IT ORDAINED, by the Slidell City Council, in  
40  
41 legal session convened, that the following described property be  
42  
43 rezoned A-9-C:  
44

45 A certain parcel of land, with all the buildings and improvements  
46  
47 thereon, lying and being situated in Division "D", Dittmar Addition  
48  
49 to the Town of Slidell (now the City of Slidell), Louisiana, and being  
50  
51 more fully described as "all of Lot Number Three (3) and the South  
52  
53 fifty (50) feet of Lot Number Two (2) in Square Number Eight (8) of  
54  
55 said Division "D" of the said City of Slidell. Said Lot No. 3 fronts  
56  
57 sixty (60.0) feet on the West side of Louisa (now Carey) Street and  
58  
59 extends westward a distance of One Hundred Twenty (120) feet between  
60  
61 equal and parallel lines. Said South fifty feet of Lot No. 2 fronts  
62  
63 fifty (50.0) feet on the West side of Louisa (now Carey) Street and  
64  
65 extends westward a distance of One Hundred Twenty (120) feet between  
66  
67 equal and parallel lines. Said parcel of land forms a rectangle  
68  
69 measuring One Hundred Ten (110.0) feet on Louisa (now Carey) Street  
70  
71 and extending westward One Hundred Twenty (120.0) feet.
