20 1/2-4. Exemptions from chapter provisions. of the Code of Ordinances  
21 of the City of Slidell.

23 BE IT ORDAINED by the Slidell City Council that Chapter 12  
24 1/2. Peddlers, Section 12 1/2-4. Exemptions from chapter provisions.  
25 of the Code of Ordinances of the City of Slidell is amended to read  
26 as follows:

31 Sec. 12 1/2-4. Exemptions from chapter provisions.  
32

33 Nonprofit organizations as defined by Chapter 2, Louisiana  
34 Revised Statute 12, shall be exempt from the provisions of this  
35 chapter upon obtaining a fee free city permit by producing a copy  
36 of their certificate of corporation as described by Louisiana Re-  
37 vised Statute 12:205 and signing the appropriate city form attest-  
38 ing to their nonprofit nature and having said form duly notarized  
39 by a licensed notary of St. Tammany Parish. Farmers selling  
40 produce raised by them or on their farms as defined in Louisiana  
41 Revised Statutes 33:4833 and Louisiana Revised Statutes 33:4834  
42 shall be exempt from the provisions of this chapter upon obtain-  
43 ing a fee free city permit by signing the appropriate city form  
44 attesting to the fact that said produce was indeed raised by them  
45 or on their farms and having said form duly notarized by a  
46 licensed notary of St. Tammany Parish. Said city permits or a  
47 copy thereof must be carried on the person(s) at all times while  
48 engaged in any activity regulated by this chapter and must be  
49 produced on demand when so requested by any official or citizen of  
50 the City of Slidell. Fee free permits issued under the provisions  
51 of this section shall be valid only from 8:00 A.M. to sunset in  
52 areas of the City zoned residential.
