An ordinance amending Chapter 17. Taxation and Licenses, Section 17-59. Power of collector to employ counsel; attorneys' fees., Section 17-63. Determination of tax due by collector; notice., Section 17-64. Protest to collector's determination of tax due., Section 17-65. Assessment of tax, interest, penalties on determination by collector., and Section 17-66. Notice of assessment., of the Code of Ordinances of the City of Slidell.

BE IT ORDAINED by the Slidell City Council, in legal session convened, that Chapter 17. Taxation and Licenses, Section 17-59. Power of collector to employ counsel; attorneys' fees., Section 17-63. Determination of tax due by collector; notice., Section 17-64. Protest to collector's determination of tax due., Section 17-65. Assessment of tax, interest, penalties on determination by collector., and Section 17-66. Notice of assessment., of the Code of Ordinances of the City of Slidell are amended as follows:

Section 17-59. Power of collector to employ counsel; attorneys' fees.

Delete the words and numbers "ten per centum (10%)" and replace with the words and numbers seventy-five dollars (\$75.00) or fifteen percent (15%), whichever is greater.

Section 17-63. Determination of tax due by collector; notice.

Delete the word and number "thirty (30)" and replace with the word and number fifteen (15).

Section 17-64. Protest to collector's determination of tax due.

Delete the word and number "thirty (30)" and replace with the word and number fifteen (15).

Section 17-65. Assessment of tax, interest, penalties on determination by collector.

Delete the word and number "thirty (30)" and replace with the word and number fifteen (15).

Section 17-66. Notice of assessment.

Delete the word and number "thirty (30)" and replace with the word and number fifteen (15).
