

25 WHEREAS, the Slidell City Council did receive a petition from

27 the City of Slidell requesting annexation and zoning from Parish to

29 A-6 Single Family Urban, and being generally located off of Camp
30
31 Villere Road, and;

33 WHEREAS, the Slidell Planning and Zoning Commission

35 such annexation and zoning on January 21, 1986, and by a publication

37 in the Slidell Daily Times on 12-17-85, 12-23-85, and 12-30-85 the City

39 Council gave notice of their intention to take action on said petition

41 by calling a public hearing on January 28, 1986 in the Council
42
43 Chambers;

45 NOW THEREFORE BE IT ORDAINED by the Slidell City Council in
46
47 legal session convened, that the following described property be
48
49 annexed into Councilmanic District D and zoned A-6:
50

51 Twenty (20) acres of land, lying and being situated
52 in Lot Three, Section Thirty-two (32) and in the
53 Northeast corner of Section Thirty-seven (37) Township
54 Eight South, Range 14 East, 9th Ward, St. Tammany
55 Parish, Louisiana, more fully described as follows:
56 From the corner common to Sections 31, 32, and 37, of
57 Township 8 South, Range 14 East, go South 62 degrees,
58 45 minutes East 22.53 chains to the Southwest corner
59 of Lot One, Section 32, and thence go South 14.71 chains
60 to the point of beginning. Thence East 19.51 chains to
61 the Westerly edge of the 100 foot road leading to Camp
62 Villere, thence South along the Westerly edge of said 100
63 foot road a distance of 10.25 chains, thence West 19.51
64 chains, thence North 10.25 chains to the point of departure.


