ORDINANCE NO. 1912

An ordinance making application to the State Bond Commission for consent and authority to hold an election on Saturday, Sept. 27, 1986 in the City of Slidell, Louisiana to renew a levy of a four point thirty-three (4.33) mill tax for the purpose of maintaining garbage disposal works and refuse and garbage collection and disposal systems within and for the City of Slidell and, in the event the election carries, for further consent and authority to renew and levy a special tax therein.

BE IT ORDAINED by the City Council of Slidell, Louisiana, acting as governing authority of said city:

SECTION I. Application is hereby made to the State Bond Commission of Louisiana for consent and authority to hold an election in the City of Slidell, Louisiana under the provisions of Sections 22 and 32 of Article 6 of the Constitution of the State of Louisiana for the year 1974; the Louisiana Election Code as amended and in particular Chapter 6-A thereof, and other constitutional and statutory authority supplemental thereto, at which election there will be submitted to the electors of the City, qualified and entitled to vote at said election, the following proposition:

PROPOSITION 2

Shall the City of Slidell, Louisiana renew a levy of a four point thirty-three (4.33) mill tax on all property subject to taxation in the City for a period of ten (10) years beginning with the year 1986, for the purpose of constructing and maintaining garbage disposal works and refuse and garbage collection and disposal systems within and for the City?

SECTION II. Application is hereby made to the State Bond Commission, in the event this proposition is carried, for its consent to levy and collect the four point thirty-three (4.33) mill tax so authorized on all the property subject to taxation in the City of Slidell, Louisiana.

SECTION III. The voting in the election shall be conducted in the sixteen (16) precincts of the City of Slidell. These precincts are as follows:

Ward 8, Precinct 5
Ward 8, Precinct 5A
Ward 8, Precinct 6
Ward 8, Precinct 6A
Ward 8, Precinct 7
Ward 8, Precinct 7A
Ward 8, Precinct 8
Ward 8, Precinct 8A
Ward 9, Precinct 1
Ward 9, Precinct 1A
Ward 9, Precinct 2
Ward 9, Precinct 3
Ward 9, Precinct 5
Ward 9, Precinct 7
Ward 9, Precinct 8
Ward 9, Precinct 10


SECTION IV. The canvass and promulgation of the results of this election shall be according to the provisions of the Louisiana Election Code. The City Council of Slidell will meet at 6:30 P.M. on September 27, 1986 in the Council Chambers at City Hall in the City of Slidell, Louisiana to examine and canvass the returns and declare the result of the election.

SECTION V. A certified copy of this ordinance shall be forwarded to the State Bond Commission together with a letter requesting the prompt consideration and approval of this application.
