21 WHEREAS, the Slidell City Council did receive a petition from
22 the Slidell City Administration requesting annexation and zoning of
23 the Lindberg Pump Station to A-6 Single Family Urban, being generally
24 located on the northwest portion of the remainder of the western
25 portion of Lot 1, Square 2, Lindberg Glenn Annex No. 1, St. Tammany

33 WHEREAS, the Slidell Planning and Zoning Commission approved
34 such annexation and zoning on February 17, 1986, and by a publication
35 in the Slidell Daily Times on 2-4-86, 2-11-86 and 2-18-86, the Slidell
36 City Council gave notice of their intention to take action on said
37 petition by calling a public hearing on February 25, 1986 in the

45 NOW THEREFORE BE IT ORDAINED by the Slidell City Council that
46 the following described property be annexed into the corporate limits,
47 of the City of Slidell, Councilmanic District E, and be zoned A-6:

51 All that certain parcel of land being designated as the
52 Northwest portion of the remainder of the Western portion
53 of Lot 1, Square 2, Lindberg Glenn Annex No. 1, St. Tammany
54 Parish, Louisiana, being more fully described as follows:

56 From the Northwest corner of said Western portion of said
57 Lot 1, also the point of beginning, go East 28.00 feet
58 along the Southerly Right-of-Way Line of a Power Line
59 Easement to a point; thence South 18.00 feet to a point;
60 thence West 28.00 feet to a point; thence go along the
61 Easterly Right-of-Way Line of Lindberg Drive North 18.00
62 feet to the point of beginning.

64 Said property is further delineated on plat of survey
65 No. 27510/28,001 by Ivan M. Borgen, C.E., dated July 24,
66 1981, revised October 5, 1981.

68 Being a portion of the property acquired by Mary Catalano
69 Culotta, et al by judgement of possession in the Succession
70 of Joseph Severio Culotta, 24th Judicial District Court,
71 Docket No. 180-169, signed June 8, 1976 and recorded in




