20 An ordinance amending Chapter 14. Sewers and Drainage.,  
21 Article I. In General., Section 14-2. Construction of private drainage  
22 facilities., subsection (a). of the Code of Ordinances of the City of  
23 Slidell.

25 BE IT ORDAINED by the Slidell City Council that Chapter 14.  
26 Sewers and Drainage., Article I. In General., Section 14-2. Construc-  
27 tion of private drainage facilities., subsection (a). of the Code of  
28 Ordinances of the City of Slidell is amended as follows:  
29

31 Section 14-2. Construction of private drainage facilities.,  
32 subsection (a): Delete the second paragraph in its entirety and  
33 replace with the following paragraph:  
34  
35

36 All commercial, residential and multi-family developments  
37 shall, unless otherwise directed by the City Engineer in writing  
38 within seven working days, be designed by the developer in such a  
39 manner that site improvements will not obstruct or impede the  
40 natural flow of storm water from adjacent property, and drainage from  
41 a development site shall be directed towards the front of the lot  
42 via a subsurface drainage system. When, during construction, there  
43 is an obstruction or impediment of storm water from or to the adja-  
44 cent property, then a temporary drainage system shall be constructed.  
45 Further, all required on site drainage improvements shall be com-  
46 pleted under a Phase I Building Permit before permits are granted  
47 for building construction. Retaining walls shall be constructed  
48 to stabilize any slope exceeding thirty degrees. All walls shall be  
49 constructed in accordance with plans and specifications approved  
50 by the City Engineer. All slopes in required yard and buffer areas  
51 shall be sodded.
