25 BE IT ORDAINED by the Slidell City Council that Chapter 3.  
26 Alcoholic Beverages., Article III. Low Content Beverage Control,  
27 Section 3-51. Renewal of permit., subsections (a) and (b) of the Code  
28 of Ordinances of the City of Slidell are amended as follows:

33 Section 3-51. Renewal of permit., subsections (a) and (b):

35 Delete these subsections in their entirety and replace with  
36 the following language:



39 (a) Persons holding permits shall file application for  
40 renewal thereof for the ensuing year and pay the annual permit fees  
41 on or before December 1st prior to the year for which the permit is  
42 issued. Renewals shall be considered delinquent on January 1st of  
43 the year for which the permit is issued. If the dealer fails to  
44 file the application and pay the permit fees by that date, there  
45 shall be added to the fee, in addition to other penalties provided  
46 in this city, a delinquency penalty of twenty-five (25) per cent if  
47 the failure is not for more than thirty (30) days, with an additional  
48 twenty-five (25) per cent for each additional thirty (30) days or  
49 fraction thereof during which the failure continues. If the dealer  
50 fails to make his application before January 1st, the city may, with-  
51 out notice or hearing, suspend his right to do business.

65 (b) Any dealer whose application for renewal is filed  
66 before January 1st may continue business until issuance of the new  
67 permit, under the previous year's permit if it has not been sus-


