ORDINANCE NO. 1967

An ordinance annexing and zoning a 2.40 acre parcel of property on the west side of Robert Road petitioned by Linda V. Wilmot and Judith A. V. LeCorgne.

WHEREAS, the Slidell City Council did receive a petition from Linda V. Wilmot and Judith A. V. LeCorgne requesting annexation and rezoning of a 2.4 acre parcel of property on the west side of Robert Road, and;


WHEREAS, the Slidell Planning and Zoning Commission approved such annexation and zoning.

NOW, THEREFORE, BE IT ORDAINED by the Slidell City Council that the following described property be annexed into Councilmanic District G and be zoned from Parish to C-2 Neighborhood Commercial:


ALL THAT CERTAIN LOT OR PARCEL OF LAND with all improvements thereon, lying and being situated in the Southwest quarter of the Southwest quarter of Section 36. Township 8 South, Range 14 East, 8th Ward, St. Tammany Parish, Louisiana, and more fully described as follows:

From the Section corner common to section 1, 2, 35 and 36 of said Township and Range, go north a distance of 1,350.8 feet to a point; thence go South 89 degrees 57 minutes East a distance of 282.9 feet to the point of beginning; thence go South 45 degrees 0 minutes East a distance of 490.4 feet to the northern right of way of Robert Road; thence go North 36 degrees 44 minutes East along the northern right of way of Robert Road a distance of 445.3 feet to a point; thence go North 89 degrees 57 minutes West a distance of 603.1 feet to the point of departure.


