ORDINANCE NO. 1976

AN ORDINANCE amending Ordinance No. 1741 adopted on July 24, 1984, providing for the levying of local or special assessments on each lot of parcel of land abutting certain streets in the subdivision of Bonfouca, City of Slidell, for the purpose of constructing waterworks improvements within such subdivision.

BE IT ORDAINED by the Slidell City Council, acting as the governing authority of the City of Slidell, Louisiana, in legal session convened, that Ordinance No. 1741:

"AN ORDINANCE providing for the levying of local or special assessments on each parcel or lot of real estate abutting: Canulette Road, Bywater Drive, Middlebrook Drive, Island Drive, Jennifer Lane, Lookout Place, Grandview Place, Bayouview Place, Little Place, Bonfouca Drive and Bayou Liberty Road, all as set out in a Notice of Intention adopted on May 12, 1983, within the corporate limits of the City of Slidell, Louisiana, in proportion that the frontage of each lot or parcel bears to all the abutting lots or parcels of real estate to be improved by the construction of waterworks facilities in accordance with the provisions of Title 33, Chapter 8, Louisiana Revised Statutes."
