20 An ordinance rezoning a parcel of property at the corner of  
21 Oleander and Palm Dr. petitioned by Concettina Lombardo wife of/and  
22 John A. Campora.  
23

24 WHEREAS, the Slidell City Council did receive a petition from  
25 Concettina Lombardo wife of/and John A. Campora requesting rezoning  
26 from M-2 Light Industrial to A-6 Single Family Urban, a parcel of  
27 property at the corner of Oleander and Palm Drive, and;

31  
32 WHEREAS, the Slidell Planning and Zoning Commission approved  
33 such rezoning.  
34

36 BE IT ORDAINED by the Slidell City Council that the following  
37 described property be rezoned A-6 Single Family Urban:  
38

40 THAT CERTAIN PIECE OR PARCEL OF GROUND, together with all  
41 the buildings and improvements thereon, and all the rights,  
42 ways, privileges, servitudes, appurtenances and advantages  
43 thereunto belonging or in anywise appertaining situated in  
44 St. Tammany Parish, Louisiana, and more fully described as  
45 follows, to-wit:  
46

47 Lot 12 of Bayou Lake Estates, as shown on plat of survey  
48 of Bayou Lake Estates, dated August 1973, approved by J.  
49 V. Burkes, III, C.E., approved by the Planning Commission  
50 of the City of Slidell on August 21, 1973, and on behalf  
51 of the City of Slidell, by its Mayor and Clerk on August  
52 28, 1973, according to which plat of survey Lot 12 forms  
53 the corner of Oleander Drive (enlarged to width of 51  
54 feet by the dedication set forth in the Act of Exchange  
55 and Dedication hereinafter referred to), and a street  
56 (which, although not named on said plat is Palm Drive,  
57 as enlarged to a width of 51 feet by the said dedication),  
58 said Lot 12 fronting 149 feet on Palm Drive (enlarged  
59 as aforesaid), with a depth and front of 95 feet on  
60 Oleander Drive, (enlarged as aforesaid), a depth on the  
61 line dividing Lot 12 from Lot 11 of 120 feet, and a first  
62 width in the rear of 29 feet on a line parallel to Palm  
63 Drive and a second width in the rear of 20 feet on a  
64 line parallel to Oleander Drive.

66 Being the same property acquired by Michael K. McInerney,  
67 et ux from Mary Helen Stall Bryant, by act of sale dated  
68 August 10, 1983, recorded in COB 1113, folio 756 of the  
69 official records of St. Tammany Parish, Louisiana.
