20 An ordinance annexing and zoning two parcels of property  
21 totaling 27.2 acres on the west side of Airport Road, north of  
22 U.S. 190 West and south of Interstate 12 petitioned by Airport  
23 Road Properties.

26 WHEREAS, the Slidell City Council received a petition  
27 from Airport Road Properties requesting annexation and zoning of  
28 two parcels of property totaling 27.2 acres on Airport Road north  
29 of U.S. Highway 190 West, and;

33 WHEREAS, the Slidell Planning and Zoning Commission  
34 recommended such annexation and zoning,

38 NOW, THEREFORE, BE IT ORDAINED by the Slidell City Council  
39 that the following described properties be annexed into Councilmanic  
40 District D and zoned from Parish to C-4 Highway Commercial.

44 All that certain parcel of land being situated in Section  
45 38. Township 8 South. Range 14 East. St. Tammany Parish.  
46 Louisiana. being more fully described as follows:

48 From the Section corner common to Sections 25 and 36, Township  
49 8 South, Range 13 East and Sections 30 and 31, Township 8 South,  
50 Range 14 East, thence East 3815.00 feet to a point; thence  
51 South 1980.00 feet to a point; thence West 8.38 feet to a point;  
52 thence South 00 degrees, 18 minutes, 31 seconds East 1433.06  
53 feet to a point; thence South 00 degree, 14 minutes, 18 seconds  
54 East 946.68 feet to the Point of Beginning, said point being  
55 situated along the Westerly Right-of-Way line of Airport Road;  
56 thence along said Westerly Right-of-Way line South 00 degrees.
