25 WHEREAS, the Slidell City Council received a petition
26 from Francis W. Bell requesting annexation and zoning of a 0.82
27 acre parcel of property on the west side of Airport Road, south of
28 Interstate 12 and north of U.S. Highway 190 West, and;

31 WHEREAS, the Slidell Planning and Zoning Commission recom-
32 mended such annexation and zoning,

35 NOW, THEREFORE, BE IT ORDAINED by the Slidell City Council
36 that the following described property be annexed into Councilmanic
37 District D and zoned from Parish R-Rural to C-6 Regional Shopping
38 Center District:

40 All that certain parcel of land being designated as Parcel B
41 situated in Section 38, Township 8 South, Range 14 East, St.
42 Tammany Parish, Louisiana, being more fully described as
43 follows:

45 From a point near the East edge of a small bayou entering
46 Bayou Liberty for the Upper Front corner of said Section 38,
47 thence South 62 degrees, 45 minutes East 1870.00 feet along
48 the line separating Sections 37 and 38 to a point; thence
49 South 12 degrees, 15 minutes East 503.50 feet to the Point
50 of Beginning.

52 Thence South 03 degrees, 30 minutes East 45.00 feet to a point;
53 thence South 67 degrees East 209.00 feet to a point; thence
54 South 46 degrees West 266.00 feet to a point; thence North
55 67 degrees West 51.00 feet to a point; thence South 31 degrees,
56 30 minutes West 46.23 feet to a point; thence North 11 degrees,
57 30 minutes East 337.62 feet to the Point of Beginning.
