18 An ordinance amending Ordinance No. 1968, an ordinance
19 rezoning a parcel of land located at Terrace and Fern Streets and
20 Old Spanish Trail.
21

22 BE IT ORDAINED by the Slidell City Council that Ordinance
23
24 No. 1968 is amended by adding the following language after line
25
26 62:
27

28 ALL THAT CERTAIN LOT OR PARCEL OF LAND lying and
29 being situated in Terrace Park Addition to the City
30 of Slidell, Parish of St. Tammany, State of Louisiana,
31 to wit:
32

33 Lots 13, 17, 18 and 19 of Square 11 of said subdivi-
34 sion. All in accordance with plat of survey by
35 H.G. Fritchie, Surveyor, dated February 24, 1928,
36 survey #658, a copy of which is on file in the
37 official records of St. Tammany Parish, Louisiana.
38

39 Being a portion of the property acquired by Gerald
40 O. Pratt from William C. Garrett, Frank B. Wood,
41 and Frank B. Wood Jr. by act dated November 25,
42 1968, recorded in COB 517, folio 242 of the official
43 records of St. Tammany Parish, Louisiana.
44

45 ALL THAT CERTAIN LOT OR PARCEL OF LAND, more fully
46 described as Lots 14, 15, and 16 of Square 11,
47 Terrace Park Subdivision Section "B" Addition to
48 the Town of Slidell, St. Tammany Parish, Louisiana.
49

50 Lot #14 measures 25 feet front on the Old Spanish
51 Trail; 134.5 feet on the Northwest line; 138.5 feet
52 on the N.E. line; going N.E. between parallel lines.
53 Lot #15 measures 25 feet front on the Old Spanish
54 Trail; 138.5 feet on the Northwest line; 142.7 feet
55 on the Northeast line going Northeast between parallel
56 lines; Lot #16 measures 25 feet front on the Old
57 Spanish Trail; 142.7 feet on the Northwest line;
58 146.9 feet on the Northeast line going Northeast
59 between parallel lines. Said Square 11 is bounded
60 Northeast by Fern Street; Southeast by Terrace Ave.;
61 Southwest by the Old Spanish Trail and Northwest by
62 Alva Street.
63

64 Being the same property acquired by Earl W. Schroeder
65 from Standard General Realty Company, Inc. by act
66 passed before Gus A. Fritchie, St. Tammany Parish
67 Notary Public, dated January 23, 1931 and recorded
68 in COB 115, folio 376 of the official records of
69 St. Tammany Parish, Louisiana.


