18 An ordinance authorizing and empowering Salvatore A.  
19 Caruso, Mayor of the City of Slidell, or his authorized representative,  
20 to receive on behalf of the City of Slidell, a parcel of land being  
21 donated to the City of Slidell by Georgia L. Owens.  
22

23 WHEREAS, Georgia L. Owens has offered to donate the  
24  
25 below described parcel of land to the City of Slidell, and;  
26

27 WHEREAS, this Council feels that accepting the donation  
28  
29 of this parcel of land from Georgia L. Owens will greatly benefit  
30  
31 the City of Slidell and its citizens,  
32

33 NOW, THEREFORE, BE IT ORDAINED by the Slidell City Council  
34  
35 that Salvatore A. Caruso, Mayor of the City of Slidell, or his  
36  
37 authorized representative, is authorized and empowered to accept and  
38  
39 receive, on behalf of the City of Slidell, from Georgia L. Owens,  
40  
41 the following described property, to wit:  
42

43 All that certain lot or parcel of land  
44 situated in the W 1/2 of the SE 1/4 of  
45 the NE 1/4 of Section 15 Township 9 South,  
46 Range 14 East, City of Slidell 9th Ward,  
47 St. Tammany Parish, Louisiana, more fully  
48 described as follows:  
49

50 From the SW corner of said W 1/2 of SE 1/4  
51 of NE 1/4 go north 200 feet to the point of  
52 beginning; thence east 300 feet; thence north  
53 100 feet; thence west 300 feet; thence south  
54 100 feet to the point of departure.

56 Acquired by James L. Crawford from John Bill  
57 Bazile by act before Gus A. Fritchie, Jr.,  
58 St. Tammany Parish Notary Ppublic, dated  
59 February 16, 1960 and recorded in COB 285  
60 folio 126.  
61

62 Said parcel has been surveyed by J.V. Burkes,  
63 C.E., bearing his number 8769, more fully  
64 shown on said survey as Lots A, B and C.  
65 The said portions A, B and C are being more  
66 fully described as follows:

17 from the point of beginning continue East a  
18 distance of 100.0 feet; thence go South, a  
19 distance of 100.0 feet; thence go North 100.0  
20 feet back to the point of beginning. Said  
21 lot being designated as Lot A.  
22

23 Commencing at the Southwest corner of t he  
24 Northeast quarter of the Northeast quarter  
25 of said Section 15, o South a distance of  
26 1020.0 feet; thence go East, a distance of  
27 100.0 feet; to the point of beginning. Thence  
28 from the point of beginning continue East, a  
29 distance of 100.0 feet; thence go South, a  
30 distance of 100.0 feet; thence go West, a  
31 distance of 100.0 feet; thence go North, a  
32 distance of 100.0 feet back to the point of  
33 beginning. Said lot being designated as  
34 Lot B.

36 Commencing at the Southwest corner of the  
37 Northeast Quarter of the Northeast Quarter of  
38 said Section 15, go South, a distance of  
39 1020.0 feet to the point of beginning.  
40 Thence from the point of beginning go East,  
41 a distance of 100.0 feet; thence go South,  
42 a distance of 100.0 feet; thence go West,  
43 a distance of 100.0 feet; thence go North,  
44 a distance of 100.0 feet back to the point of  
45 beginning. Said lot being designated as Lot C.  
46

47 Being the same property acquired by Deed from  
48 James L. Crawford before S.W. Provensal,  
49 Notary Public, dated May 4, 1973 and further  
50 acquired by Quitclaim from Margaret C. Lindsay  
51 dated June 11, 1978.

53 Being the same property acquired by Judgment  
54 of Possession in the Succession of Arthur  
55 Neal Owens, Sr., M.D., No. 11215 of the 22nd  
56 Judicial District Court for the Parish of  
57 St. Tammany, dated April 8, 1986, registered  
58 in St. Tammany Parish in COB 1252, page 425.
