19 BE IT ORDAINED by the Slidell City Council that Ordinance

23 An ordinance providing for the levying of local or special assessments
24 on each parcel or lot of real estate abutting: Canulette Road, Bywater
25 Drive, Middlebrook Drive, Island Drive, Jennifer Lane, Lookout Place,
26 Grandview Place, Bayouview Place, Little Place, Bonfouca Drive and
27 Bayou Liberty Road, all as set out in a Notice of Intention adopted
28 on May 12, 1983, within the corporate limits of the City of Slidell,
29 Louisiana, in proportion that the frontage of each lot or parcel bears
30 to all the abutting lots or parcels of real estate to be improved
31 by the construction of waterworks facilities in accordance with the
32 provisions of Title 33, Chapter 8, Louisiana Revised Statutes.




