20 BE IT ORDAINED by the Slidell City Council that Ordinance  
21  
22 Number 1741:

23  
24 An ordinance providing for the levying of local or special assessments  
25 on each parcel or lot of real estate abutting: Canulette Road, Bywater  
26 Drive, Middlebrook Drive, Island Drive, Jennifer Lane, Lookout Place,  
27 Grandview Place, Bayouview Place, Little Place, Bonfouca Drive and  
28 Bayou Liberty Road, all as set out in a Notice of Intention adopted  
29 on May 12, 1983, within the corporate limits of the City of Slidell,  
30 Louisiana, in proportion that the frontage of each lot or parcel bears  
31 to all the abutting lots or parcels of real estate to be improved  
32 by the construction of waterworks facilities in accordance with the  
33 provisions of Title 33, Chapter 8, Louisiana Revised Statutes.




