18 An ordinance annexing and zoning Lot No. 1, Indiana
19 Avenue, from Parish Suburban Agricultural to A-6, Single Family
20 Urban, petitioned by Debra Landry Diecidue.

22 WHEREAS, the Slidell City Council received a petition
23
24 from Debra Landry Diecidue requesting annexation and zoning of
25
26 Lot No. 1, Indiana Avenue, and;

27
28 WHEREAS, the Slidell Planning and Zoning Commission has
29
30 approved such annexation and zoning.

31
32 NOW, THEREFORE, BE IT ORDAINED by the Slidell City Council
33
34 that the following described property be annexed into Councilmanic
35
36 District D and be zoned from Parish Suburban Agricultural to A-6,
37
38 Single Family Urban:

40 ALL THAT CERTAIN PIECE OR PARCEL OF GROUND, together
41 with all the buildings and improvements thereon, and
42 all the rights, ways, privileges, servitudes, appur-
43 tenances, advantages and component parts thereunto
44 belonging or in anywise appertaining, situated in the
45 Parish of St. Tammany, State of Louisiana, and more
46 fully described as follows, to wit:

47
48 Lot No. One (1) of Segari Addition, a subdivision of
49 Lot Five (5) of Section Three (3) Township Nine (9)
50 South, Range Fourteen (14) East. In accordance with
51 map of survey made by H. G. Fritchie, dated July 12,
52 1956, his number 1732.

53
54 Said Lot No. One (1) is bounded on the East by Lot
55 No. 2 of said subdivision along which it measures
56 192.0 feet; it fronts 80.0 feet on Minturn Road
57 along which it measures North 87 degrees, 20 minutes
58 West. The North line of said Lot No. One (1) bears
59 South 85 degrees, 20 minutes East and measures 32.1
60 feet; the West line of said Lot No. (1) bears North
61 18 degrees, 42 minutes East and measures 210.0 feet.

63 Being the same property acquired by Leland L. Landry,
64 Jr., et ux from Leland L. Landry, et ux by act dated
65 June 30, 1981 and recorded in COB 1022, folio 337 St.
66 Tammany Parish, Louisiana.
