19 An ordinance of the City of Slidell, Louisiana levying  
20 a special tax of twenty one hundredths (.20) mill on the dollar on  
21 all taxable property in the City of Slidell, Louisiana, suffi-  
22 cient to pay maturing bonds and interest of the 1958 Sewerage  
23 Public Improvements Bonds of the City of Slidell, Louisiana for  
24 the year 1988.

26 SECTION 1. BE IT ORDAINED by the City Council of the  
27 City of Slidell, Louisiana, in legal session convened, that there  
28 is hereby levied a special tax of twenty one hundredths (.20) mill  
29 on the dollar on all taxable property under the laws of the State  
30 of Louisiana, situated in the City of Slidell, according to the  
31 assessment roll of the said City for the year 1987.

35 SECTION 2. BE IT FURTHER ORDAINED that the said special  
36 tax is levied for the purpose of providing an amount sufficient to  
37 pay interest and maturing bonds for the Sewerage Public  
38 Improvements Bonds of Sewerage District Number 1-A of the City of  
39 Slidell, Louisiana, for the year 1988 as duly authorized by a  
40 special taxpayer election held July 23, 1957 and by a Resolution  
41 of the Mayor and the Board of Aldermen of the City of Slidell,  
42 Louisiana, passed on the 28th day of April, 1958.
