19 An ordinance of the City of Slidell, Louisiana levying
20 a special tax of forty one hundredths (.40) mill on the dollar on
21 all taxable property in the City of Slidell, Louisiana, suffi-
22 cient to pay maturing bonds and interest of the 1974 Road
23 Improvement Bonds of the City of Slidell, Louisiana, for the year
24 1988.

26 SECTION 1. BE IT ORDAINED by the City Council of the
27 City of Slidell, Louisiana, in legal session convened, that there
28 is hereby levied a special tax of forty one hundredths (.40) mill
29 on the dollar on all taxable property under the laws of the State
30 of Louisiana, situated in the City of Slidell, according to the
31 assessment roll of the said City for the year 1987.

32
33 SECTION 2. BE IT FURTHER ORDAINED that the said special
34 tax is levied for the purpose of providing an amount sufficient to
35 pay interest and maturing bonds for the 1974 Road Improvement Bonds
36 of the City of Slidell, Louisiana, for the year 1988, as duly
37 authorized by a special taxpayers election held December 15, 1973,
38 and by a Resolution of the Mayor and the Councilmen of the City of
39 Slidell, Louisiana, passed on the 18th day of December 1973 and
40 January 22, 1974.
