
ORDINANCE NO. 2098


An ordinance establishing maximum salaries/retainers for the Mayor, all unclassified employees of the executive branch, members of the City Council, employees of the City Council, the Chief of Police, unclassified employees of the police department, the City Attorney and the City Prosecutor, the City Judge, the City Marshall, and the Clerk of Court for the Fiscal Year 1987-88.

BE IT ORDAINED by the Slidell City Council, in legal session convened, that the following maximum salaries/retainers are established for the Mayor, all unclassified employees of the executive branch, members of the City Council, employees of the City Council, the Chief of Police, unclassified employees of the police department, the City Attorney, the City Prosecutor, the City Judge, the City Marshall and the Clerk of Court for the Fiscal Year 1987-88 in accordance with Section 2-13 of the Code of Ordinances of the City of Slidell:
